Social Media Policy 2024-25

Social media allows individual to provide their thoughts, reply to others, and share exciting moments, experiences and achievements in our Sport.

Cook Islands Modern Pentathlon (CIMP) believe the social media has a valuable and vital role to play in the sport of Modern Pentathlon, both in Cook Islands, New Zealand and Internationally, and can serve increase athletes and the profile of the sport.

The purpose of this document is to provide members with guidance when posting on social media, and to detail CIMP's principles and requirements, as well as potential consequences if applicable.

For this policy, social media includes, but is not limited to:

- Blogs/Vlogs
- Social networks
- Mobile phone applications
- Messages via a digital device.

Guiding Principles

The following guiding principles are the core of this policy.

Area	Details
Social Media Posts	<ul style="list-style-type: none">• Information shared on social media appears in public so careful consideration should be given to content before it is posted.• Information shared within online communities could have implications for the sport and those associated with it.• Information shared online can be difficult, if not impossible, to retract. A comment may be able to be removed but the very nature of social media encourages a person to share information which makes it difficult to know where the information may finish up.• You should assume that all posts and information shared via social media can be traced back to you.• People will make assumptions about what you're like based on what you write and say.• When sharing information online, remember that you may be considered as holding yourself out as a spokesperson for CIMP.• If in doubt don't post it!
Defamation	<ul style="list-style-type: none">• Do not make defamatory, disrespectful and hateful comments about individuals or organizations.• Do not insult or say anything that could be construed as offensive.

The reputation of Modern Pentathlon	<ul style="list-style-type: none"> You should not bring CIMP or the sport of Modern Pentathlon into disrepute. The use of obscene language and threatening comments targeted at an individual or organization will not be tolerated. Comments which are contrary to the spirit and integrity of sport will not be tolerated.
Uniform	<ul style="list-style-type: none"> When you are wearing a local or Cook Islands Modern Pentathlon Uniform, it is important to remember that you are representing the sport and should not bring the sport or the association into disrepute. This needs to be kept in mind when taking photos, or providing social media posts.
Olympics / Para Olympics	<ul style="list-style-type: none"> If selected to participate on other teams or in major events such as the Olympic Games and Paralympic Games, you may also be required to adhere to the guidelines imposed by the governing bodies of those organizations.

Consequences of failing to adhere to this policy

- If you fail to follow these guidelines, CIMP has the right to issue you with a take-down notice. Representatives who are found to not comply with a take-down notice will face disciplinary action.
- Repeated breaches of this policy could lead to disciplinary action. CIMP also has the right to administer sanctions and take legal action.
- In addition, as with any form of public communication, online communication can also be subject to legal proceedings. You should be mindful that unsubstantiated claims, false statements, defamatory, offensive and threatening comments could lead to prosecution.
